We have considered your clarifications/replies against our Audit queries while preparing your this Audit Report for Birnagar Municipality for the year 2014-15.

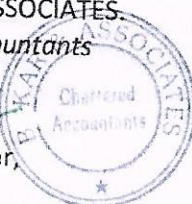
