1.(i) Separate e-tenders (1st) are invited by the Chairman, behalf of the Birnagar Municipality for the works mentioned in the list given above through electronic tendering (e-Tendering) from eligible and resourceful contractors having sufficient credential and financial capability for execution of works of similar nature.

(ii) Intending bidders desirous of participating in the e-tender are to log on to the website <https://wbtenders.gov.in> for the tender.

(iii) Bidders willing to take part in the process of e-Tendering are required to obtain Digital Signature Certificate (DSC) from any authorized Certifying Authority (CA) under CCA, Government of India (viz. NIC, nCode Solution, Safes crypt, e-Mudhra, TCS, MTNL, IDRBT). DSC is given as a USB e-Token. After obtaining the Class 2 or Class 3 Digital Signature Certificate (DSC) from the approved CA they are required to register the fact of possessing the Digital Signature Certificates through the registration system available in the website.

(iv) Tenders are to be submitted online and intending bidders are to download the tender documents from the website stated above, directly with the help of the e-Token provided. This is the only mode of collection of tender documents. Details of submission procedure are given below under "General terms and conditions and information".

(v) Last date & time of submission of bids online is **29.05.2023 up to 06.00 PM**

The intending bidders must read the terms and conditions of the NleT carefully. They should particularly go through the eligibility criteria required and satisfy themselves of the requirements for eligibility. They should only submit their bid if they consider themselves eligible and they are in possession of all the documents required.

All information posted on the website consisting of NleT and related tender documents, BOQ, Corrigendum, etc. and Drawings, if any, shall form part of the tender document.

2. Scope of work :

The aim of this Tender is to increase the amenity value of Birnagar town by providing luminous streets, roads, parks, water bodies, etc., which will be certainly helpful to the citizen on safety & security point of view that's why the installation of High Mast Lights becomes very important.

1) In the event of e-filling, intending bidder may download the tender documents from the website <http://wbtenders.gov.in> directly with the help of Digital Signature Certificate. Necessary cost of tender documents (tender fees) and Earnest Money may be remitted by selecting from either of the following payments modes:-

ii) RTGS/NEFT in case of offline payment through bank account in any Bank and also to be documented through e-filling.

2) Both Technical Bid and Financial Bid are to be submitted concurrently duly digitally signed in the website <http://wbtenders.gov.in>

3) Tender documents may be downloaded from website and submission of Technical Bid and Financial Bid will be done as per Time Schedule stated in Sl. No.-6.

4) The FINANCIAL OFFER of the prospective bidder will be considered only if the TECHNICAL BID of the bidder is found qualified by the Tender Evaluation Committee' formed by the authority of Birnagar Municipality The decision of the 'Tender Evaluation Committee' will be final and absolute in this respect. 7. Earnest Money: Earnest money (2% of the estimated amount put to tender) shall be remitted by the tenderer through ICICI Payment Gateway or through net-banking or NEFT or RTGS in respect of tender ID. Every such transfer shall be done on or after the date of publish of NleT. Any tender without such online payment of EM (Except exemption as per G.O.) shall be treated as informal and shall be automatically cancelled. Online transfer of Earnest Money receipt (scanned copy) shall be uploaded as statutory document. Such 2% of earnest money will automatically converted into the Security Deposit in respect of successful tenderer.

8. Duration of Empanelment : Tenure of contract will initially be for a period of one year from the date of work order which may be suitably extended after reviewing performance and continuation of the project.

9. The TIA will accept the tender. He/She does not bind himself/herself to accept otherwise the lowest tender and reserves to himself/herself the right to reject any or all the tenders received without assigning any reason thereof as per the approval of competent authority i.e. The Chairman of Birnagar Municipality.

10. Prequalification Criteria

Bidder must meet the following Technical criteria & Additional Criteria :

Enlisted Contractors and/or outside bonafide contractors, Engineers Co-Operative Societies, Consortiums and Partnership Firms registered under the relevant Act and Contractors of equivalent grade/Class registered with Central Govt./MES/Railways for execution of civil works are eligible on the criteria as detailed in the Website (<https://wbtenders.gov.in>). Joint Venture Firms are not eligible to participate.

11. The Prospective Bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of 5 (Five) year from the date of successful completion of the work to the entire satisfaction of the Authority. If any defect / damage is found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect.

12. The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works/sample of the goods to be supplied and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, before submitting offer with full satisfaction, the cost of visiting the site shall be at his own expense.

13. The intending Bidders shall clearly understand that whatever may be the out come of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The tender accepting authority through a Tender Evaluation Committee reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Bidder up to the stage of Bidding.

14. Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Instructions to Bidders' stated in Section - 'A' before tendering the bids.

15. Conditional / Incomplete tender will not be accepted under any circumstances.

16. The intending Bidders are required to quote the rate *online*.

17. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.

18. The Chairman, reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.

19. If there be any objection regarding prequalifying the Agency that should be lodged on line to the Chairman of Tender Evaluation Committee within 2 (two) days from the date of publication of list of qualified agencies and beyond that time schedule no objection will be entertained by the Tender Evaluation Committee.

20. Before issuance of the WORK ORDER, the tender inviting authority may verify the credential and other documents of the lowest bidder if found necessary. After verification if it is found that the documents submitted by the lowest bidder is either manufactured or false in that case work order will not be issued in favour of the said Bidder under any circumstances.

21. WORK ORDER will be issued after receipt of Administrative approval of the authority if other terms and condition are fulfilled.

22. Qualification Criteria:

The tender inviting and Accepting Authority through a "Tender Evaluation Committee" will determine the eligibility of each bidder. The bidders shall have to meet all the minimum criteria regarding:

- 1) Financial Capacity
- 2) Technical Capability comprising of personnel & equipment capability
- 3) Experience / Credential

The eligibility of a bidder will be ascertained on the basis of the document(s) in support of the minimum criteria as mentioned above and the declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly notarized. If any document submitted by a bidder is either manufactured or false in such cases the eligibility of the bidder /bidder will be rejected at any stage without any prejudice.

23. Escalation of Price on any ground and consequent cost over run shall not be entertained under any circumstances. Rates should be quoted accordingly.

24. Tendering authority/Engineer in charge reserves the rights for the selection of makes/brands and quantity of all materials/equipments mentioned in the BOO or vendor list. More than one make/brand and quantity may be asked to utilize for the execution of the work for the interest of Municipality to ensure best quality of work. The authority would provide consent/ permission regarding make/ brand and quantity of materials mentioned in the BOO/ Vender list, the agency have to carry out accordingly otherwise may lead to cancellation of agreement and forfeit of security deposit/earnest money whichever is more. The intending bidders may be requested to quote the rates keeping all these conditions in mind.

25. The complete installation within this contract shall be guaranteed against any manufacturing defects and or bad workmanship for a period as mentioned Government of West Bengal Law & Arbitration Cell Public Works Department G.O. No. 5784-PW/L&A/2M-175/2017 Dated: 12.09.2017 from the date of final taking over of the installation by the ultimate users. During this period any defects brought to the notice of the contractor by the department shall be replaced / repaired / mend good as the case may be at free of cost.

26. The LED Luminaries within this contract shall be guaranteed for a period of sixty (60) months from the date of final commissioning at site. Guarantee certificate duly signed and stamped not below the rank of regional manger/ senior officials from the manufacturer shall have to be submitted before the final bill. Scanned copy of Self declaration on letter head to be uploaded stating above along with other documents with NIT as non-statutory documents.

27.) Additional performance security shall have to submit as per GO No.4608-F(Y) Dt.18.07.2019 if the quoted rate 80% or less of the tender amount

28. Eligibility criteria for participation in the tender.

i) The prospective bidders shall have satisfactorily completed prime agency at least one work of similar nature in a single contract within last five (5) years under authority of State / Central Govt., State /Central Govt. The Agency will be liable to maintain the work at working portion at the appropriate service level to the satisfaction of the Engineer-in-Charge at his own cost for a period as per prevailing Govt. rule from the date of completion of the work. If any defect/damage is found during the period as mentioned above contractor shall make the same good at his own cost expense to the specification at par with instant project work. Failure to do so, penal action against the Agency will be imposed by the Department as deem fit. The Agency will have to quote his rate considering the above aspect.

36. Running payment of work may be made to the executing agency as per availability of the fund. The executing agency may not get a running payment unless the gross amount of running bill is at least 40% of the tendered amount.

37. A warranty of LED Light for 5 (five) years shall have to be submitted by the bidder.

a) The OEM authorization letter of tender specified OEM at least of brands should be included with a technical bid & OEM should have serviced by the bidder.

39. OEM authorization/warranty to be signed either by Area Manager or Equivalent Category Executive.

40. Above all items should be supply in brand of (CGL/Philips /Bijaj /Crompton/Havells). All Fittings should be made in INDIA (The authority of Birnagar Municipality reserves the right to accept or reject any brand without assigning any reason).

41. Once the Supply, Installation, Testing & Commissioning work for the said project will be fully certified by the Engineer then the relevant payment will be processed.

42. Security Deposit @ 8% (eight percent) will be deducted from each and every running bill. The amount of such 10% (ten percent) of Security Deposit (Initial 2% EM + additional 8%) will be refunded to the successful tenderer without any interest in the following manner, as applicable.

(a) For work with three months Defect Liability Period:

(i) Full security deposit shall be refunded to the agency on expiry of three months from the actual date of completion of the work.

(b) For work with one year Defect Liability Period:

43. Additional Performance Security @ 10% of the tender amount shall be obtained from the successful bidder if the accepted bid value is 80% or less of the estimate put to tender.

The Additional Performance Security shall be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptance, his/her Earnest Money will be forfeited and other necessary actions as per

NIT like blacklisting of the agency, etc. may be taken. The Bank Guarantee shall have to be valid up to end of the Contract Period and shall be renewed accordingly, if required.

The Bank Guarantee shall be returned immediately on successful completion of the contract. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the contract period after serving proper notice to the agency.
